The district's current enrollment is approximately 1,800 students with an average attendance rate of 94%.

The applicant must possess a valid Ohio Treasurer's license. Successful experience as a School Treasurer is preferred but not required. The CFO must maintain integrity and high standards of ethics in all matters. The successful candidate will demonstrate the following financial leadership characteristics:

- An individual who can skillfully provide financial leadership for the district;
- Proven ability to work collaboratively with others inside and outside the district a team player;
- Strong financial and detail-oriented reporting skills;
- Ability to facilitate educational discussions/decisions through a financial lens;
- Demonstrated excellent inter-personal and effective communication skills;
- Demonstrated knowledge of state and local funding issues, Ohio laws and regulations pertaining to public schools;
- Experience in effective process management and organizational skills;
- Leadership skills for staff and various finance committees;
- Experience with levy laws and working knowledge of TIF's and Joint Economic Development Districts;

Just A Little History of Hardin County and Kenton...

Location: 40.6606 N Latitude, 83.6636 W Longitude Hardin County is located in northwest Ohio. Kenton is the county seat and approximately 57 miles northwest of Columbus. Almost all the major routes in Hardin County meet in Kenton, which was named after Simon Kenton. He was a frontiersman who settled in nearby Urbana, Ohio.

The "Crazy Eights", CSX transportation engine SD40-2 #8888, unmanned train incident in 2001 that rumbled 66 miles through Northwest Ohio. The train was stopped just southeast of Kenton. The incident later inspired the 2010 motion picture <u>Unstoppable</u>.

Kenton City School district, includes an elementary school, Kenton Middle School, Kenton High School and a Satellite Career Center of Hi-Point CTC. Kenton Elementary School is a new facility opened in 2014 which replaces the three previous elementary and one kindergarten buildings.

The Kenton High School are the "Wildcats". The Wildcat football team won consecutive state championships in 2001 and 2002 in division IV, runner-up in 2011 in Division IV, and runner-up in 2003 in Division III.
